Dear Assemblyman Cahill:

The Kingston Interfaith Council demands the full resources of your office to assist with the development of the Kingston Meadows Senior Residence, an independent living complex targeted to senior citizens over the age of 62 years who are on fixed incomes.

For almost a decade, the Hudson Valley Housing Development Fund Company, Inc., a not-for-profit organization that has developed more than 300 apartments in the Mid-Hudson Region, has been completing the documents required for local approvals and at this point in time only ***requires a crossing over the County owned Ulster & Delaware (U & D) Railroad bed.***

As the City of Kingston has not had senior housing built for more than 16 years, and as a 2009 Needs Assessment documented a need for more than 1,000 new apartments in the City of Kingston by the years 2020, and less than 100 apartments have been built to date, there is an extraordinary needs for senior housing in the City of Kingston.

Hudson Valley Housing has developed and managed affordable housing for more than 30 years and has a well-established track record of high-quality housing.

Your office has the ability to assist this development in securing its final approval and the members of the Kingston Interfaith Council respectfully request that your office do so.
